

DOVE WEDDING PHOTOGRAPHY

Contract: Terms & Conditions

PLEASE READ TERMS AND CONDITIONS OF CONTRACT.

It is mutually agreed that the following Terms of Agreement form an integral part of this Contract and that no variation or modification of this Contract shall be effective unless accepted by both Dove Photography and the Client, in writing.

BOOKING FEE

A non-refundable booking fee of £200 is required at the time of booking, together with a signed contract. Dates are reserved only when this deposit is paid by cash, cheque or bank transfer. Please make cheques payable to Dove Photography. The booking fee paid will be deducted from your final order and is not normally refundable.

BALANCE OF PAYMENT

The balance of payment, as stated on the booking confirmation letter from Dove Photography, is to be made not later than 28 days prior to the Wedding Ceremony. Payment for additional album photographs, prints & frames is made after the wedding at the time of ordering.

FEES

The booking fee and balance of payment make up the fee and include all photography and your package of choice as confirmed on the booking form overleaf.

CREATIVE LICENCE

Dove Photography shall be granted creative and artistic license in relation to the choice of locations and poses used. Dove Photography's judgment on photographic style and the number of photographs taken shall be deemed correct. Some photographs may not be possible due to changes of the weather and the availability and willingness of subjects. The Client is liable to ensure that everyone who appears on photos agrees to their reproduction and use in accordance with these conditions. Dove Photography will do their best to honour requested photographs but do not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement. Colour match not guaranteed

EXCLUSIVITY

Dove Photography shall be the sole professional (still) at the venues specified. We do however encourage family, friends, and other guests to take photographs throughout the day.

FORCE MAJEURE

In the unlikely event of total photographic failure, injury or sickness or any other matters beyond our control, liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected. Dove Photography has full Public Liability and Professional Indemnity Insurance.

CANCELLATION

If Dove Photography have to cancel this Contract for reasons beyond their control (death, injury, sickness, etc), their liability shall be limited to a full refund of all monies paid. If the client cancels this contract after a period of 14 days from the date of signing the Contract the following charges apply as a percentage of the total fee due as compensation for loss of income for Dove Photography

Number of days before the wedding	
30 days or less	100%
31-60 days	75%
61-120 days	50%

Should the cancelled wedding turn out to be a postponement then, subject to Dove Photography's availability, all monies paid may be applied to the new wedding. In this case, the total fee chargeable shall be the fee which applies at that time. In the event that Dove Photography take another wedding booking for your cancelled or postponed date (*without being under any obligation to do so*) a full unconditional refund of your deposit and monies paid shall be made.

INTEREST ON LATE PAYMENT

30 day terms.

COMPLAINTS PROCEDURE

Please address any complaints to Dove Photography either by email, telephone or letter as per our contact details overleaf. We will endeavour to respond to any complaint within 2 working days of receipt.

PRIVACY

Dove Photography will store your name and wedding details on a private internal database. These details will not be made available to third parties. Should you wish to have your details removed from our database, please advise us in writing to the address above. Images are available for 3 years and will be deleted after 4 years. Payment of £50 for archive retrieval

COPYRIGHT - The 1998 Copyright, Designs and Patents Act assigns All Copyright to Dove Photography.

The Client hereby allows the Photographer to display any images covered by this Agreement and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles, and other such media without any remuneration being due to the Client or any people featured in the photographs, provided that the images are used lawfully and without damage to the Client. Images placed in password protected galleries within the website are not available to the general public in the normal course of events. However it may not always be possible to prevent determined persons from accessing these galleries. If the Client does not wish to be bound by the conditions as above please inform Dove Photography in writing, using the contact details overleaf.

JURISDICTION COURTS AND LAWS OF ENGLAND AND WALES

The Client may copy the photographs on the CD and use them for their own personal use. They may not be published or used commercially.

In the event that payment is not made and further action is taken to recover money owed, all discounts will be withdrawn and full payment will be invoiced.
